

ILMS 2014 Club and / or Team Registration

There are several changes from prior year registrations:

- First online renewal is preferred. Grab a credit card and Go to <http://www.usms.org/reg/club/>
- Only use this written form if you must pay by check.
- Club fees have been reduced to \$25.
- Team fees are still \$25, but you pay USMS not ILMSA. As an added benefit in the 2014 registration your Team is entitled to the same benefits as USMS clubs. Your Team will receive sample USMS marketing materials, a 2014 rule book unless you opt out in the registration process, communications from USMS and a free Team banner co branded with USMS once every 4 years.

And there are the advantages of being a Team which remain unchanged:

- Your Team, (also known as a "workout group, sub-group" or "Chapter") has registered under the Club Illinois Masters (IM) which is the Illinois "regional club" registered and acknowledged as a Club under ILMSA, a local masters swim committee (LMSC) under USMS.
- If competing, members of your Team will compete under your Team in ILMSA sanctioned events -- for the most part those are events that occur anywhere in Illinois (except those few counties around St. Louis that fall within the Ozark LMSC.)
- For all events occurring outside of Illinois, your swimmers will swim under the IM Club and they will be able to join with swimmers from other IM Teams for relays. This has repeatedly proved to be valuable for our swimmers who compete in the USMS SC and LC Nationals, where IM fielded over 24 relays in 2013, with most finishing in the top 5! However, regardless of the in-state or out-of-state venue, your swimmers times will be attached to your Team for ILMSA statistics.

Swimmers will begin to renew their memberships on November 1st. Be aware that a swimmer CANNOT choose a Team that has not yet renewed. If your Team has not renewed its registration by November 1st, a swimmer will have to select "Unattached," or choose a different Team, or elect not to register at all.
